State Law Pitfalls: Don't Step in it When Your Clients Step Across State Lines

Dr. Gerry w. Beyer Professor of Law—Texas Tech University School of Law

During this presentation, Prof. Beyer discusses the issues which a estate planner should consider when planning an estate for the possibility that a client's property may end up being governed by the law of another state and the planning steps that should be considered.

Objective: Ascertain the law governing a client's estate. Recognize the issues that arise with regard to: will execution formalities, changed circumstances after will execution regarding property, changed circumstances after will execution regarding people, interpretation and construction of wills and trusts, and estate administration

Dr. Gerry W. Beyer is Governor Preston E. Smith Regents Professor of Law at the Texas Tech University School of Law. Prof. Beyer received his J.D. from The Ohio State University (1979) and his LL.M. (1983) and J.S.D. (1990) degrees from the University of Illinois. He is a member of the Order of the Coif, an Academic Fellow and Regent of the American College of Trust and Estate Counsel, a member of the American Law Institute, was inducted into the Estate Planning Hall of Fame, and was awarded the Distinguished Probate Attorney Lifetime Achievement Award by the Real Estate, Probate, and Trust Law Section of State Bar of Texas.
