# **Economic Update for the US and Tennessee**

## Dr. Marianne Wanamaker

#### Professor—University of Tennessee

#### Executive Director—Howard H. Baker Jr. Center for Public Policy

How has the US recovered from the COVID-19 pandemic in terms of output and employment? How has Tennessee fared compared to other parts of the country, and what lies ahead for the US economy as we battle inflation, tight labor markets, and geopolitical uncertainty?

**Objective:** Attendees will gain an understanding for economic trends in the nation and state and the effects of inflation, labor markets, and world politics on the economy.

**Marianne Wanamaker** Is an associate professor of economics at the University of Tennessee and the executive director of the Howard H. Baker Jr. Center for Public Policy. She serves as a research associate at the National Bureau of Economic Research and as a research fellow at the Institute of Labor Economics (IZA) in Bonn, Germany and at the University of Stellenbosch, South Africa. She serves as co-editor of *Explorations in Economic History* and is the former chief domestic economist at the White House Council of Economic Advisors. Dr. Wanamaker's expertise is in labor economics, education, and workforce development. She holds an undergraduate degree from Vanderbilt University and her masters degree and PhD from Northwestern University.
